

DECLINING THE OFFER OF REDRESS

This is the **approved form** for declining an offer of redress under section 45 of the *National Redress Scheme for Institutional Child Sexual Abuse Act 2018*.

The applicant or their legal nominee can use this form to **decline the offer of redress**. If this form is completed and returned to the National Redress Scheme (the Scheme), the offer will be declined. This means the applicant will no longer be able to request a review of their redress offer, make another application to the Scheme, or later decide to accept the offer.

How to tell us about your decision

Complete this form and return it to the Scheme **before** the end of the acceptance period included in the applicant's redress outcome letter.

OR

Do nothing and let the acceptance period end. The day after your acceptance period ends, the Scheme will understand that I/the applicant:

- **have/has chosen not to accept** the redress offer meaning it is declined
- will not apply for a review of the redress offer, if a review is available
- cannot make another application to the Scheme, and
- if applicable, will repay the \$10,000 advance payment of redress to the Commonwealth.

This will not apply if the applicant already applied for a review, and the review has not yet been completed at the end of the acceptance period.

If you need more time to decide, contact the Scheme on **1800 737 377**. The Scheme cannot extend the acceptance period after this completed form is received.

I acknowledge that by declining the offer of redress made, the participating institution(s) determined as responsible to provide redress, are not released from civil liability for the abuse that I/the applicant experienced, and that the option to take civil proceedings against the institution(s) may remain open to me/the applicant.
